

## Who Has the Right of Way—Motorists or Pedestrians?

Pedestrians have the legal right-of-way when they are in a marked crosswalk

### Tips for Motorists

- ☐ Be watchful for people walking and bicycling; obey all speed limits; avoid distractions; and know the laws pertaining to pedestrian right-of-way.
- ☐ Be prepared to yield to pedestrians in crosswalks (marked or unmarked).
- ☐ Never pass a vehicle that is stopped for a pedestrian.
- ☐ Before making a turn, be sure the path is clear of any pedestrians.
- ☐ Slow down in areas where you are likely to find people walking, such as near bus stops, schools, playgrounds or intersections.

# Crosswalk Safety

## What are Crosswalks?

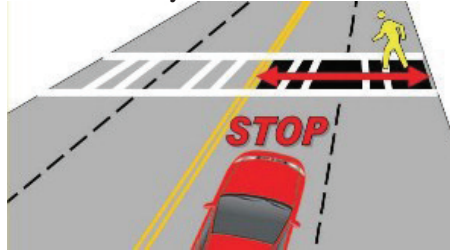
A crosswalk is a designated point on a road at which some means are employed to assist pedestrians wishing to cross.

- They are designed to keep pedestrians together where they can be seen by motorists, and where they can cross most safely.
- Marked crosswalks are installed to clearly define a path for pedestrians to cross the street. Crosswalks often have signs or traffic signals supporting them and controlling traffic or warning drivers that someone might be crossing.



## Pedestrian + Crosswalk = STOP !

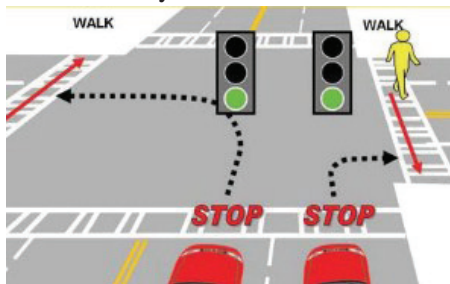
Yield to a pedestrian even if the pedestrian is not within your lane.



**STOP** for a pedestrian in a crosswalk when the pedestrian is anywhere on your side of the road.



**STOP** for a pedestrian in a crosswalk when the pedestrian is approaching and in the lane next to your side of the road.



## NEVER PASS A CAR STOPPED AT A CROSSWALK !

A pedestrian may be crossing and hidden from your view. When stopping for a pedestrian, stop far behind the crosswalk so other drivers can see the person crossing.

## Traffic Violations to Avoid

21453(b) CVC—Fail to yield to pedestrian while making right turn at a red light

21950(a) CVC—Fail to yield to a pedestrian in a crosswalk

21951 CVC—Passing vehicle stopped for pedestrian

21952 CVC Fail to yield to pedestrian while crossing sidewalk
