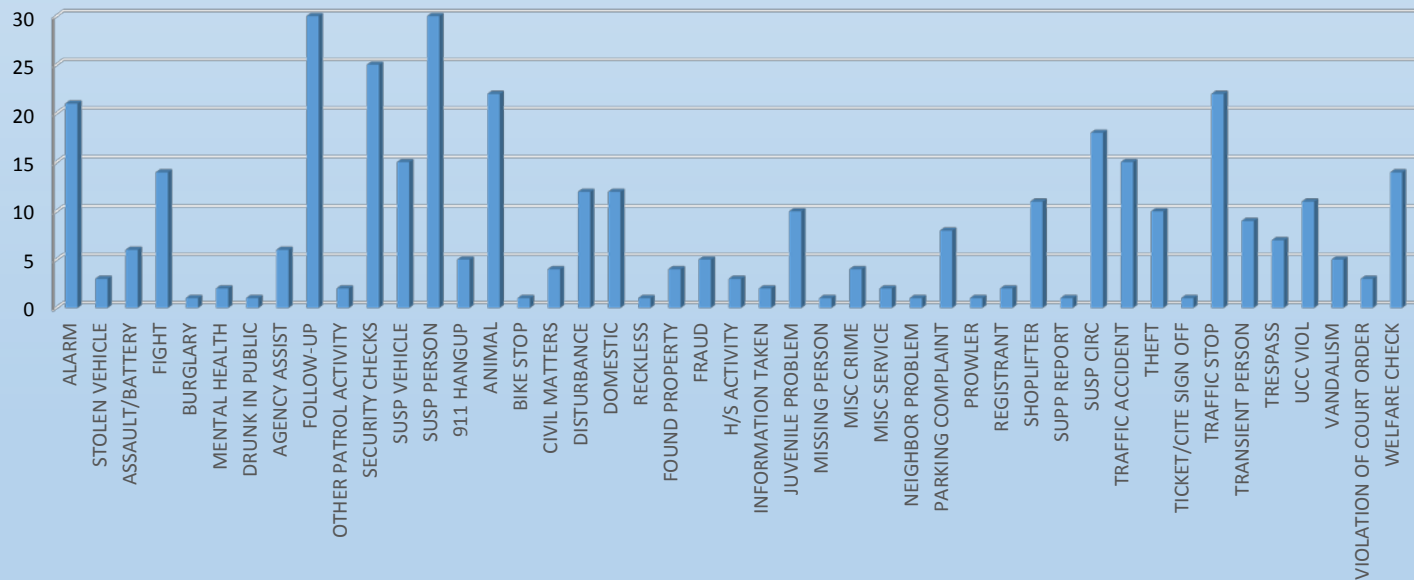

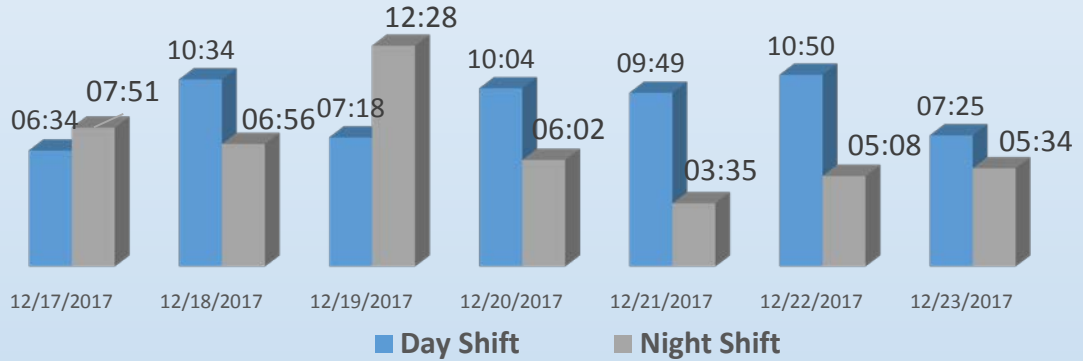

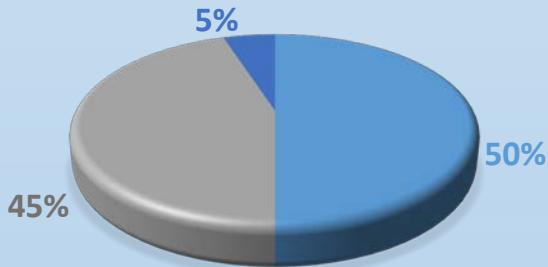
Daily Average Response Times (mm:ss)



The Patrol Division's response time to in-progress calls was just over 3 minutes.

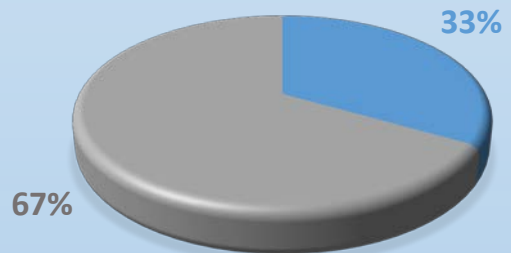
The average response time to all calls was just over 7 minutes.

CRIME BREAKDOWN



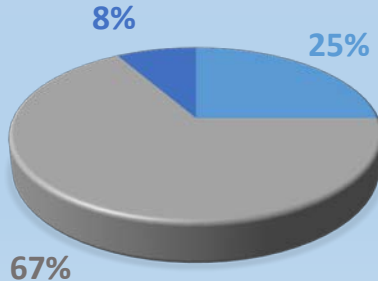

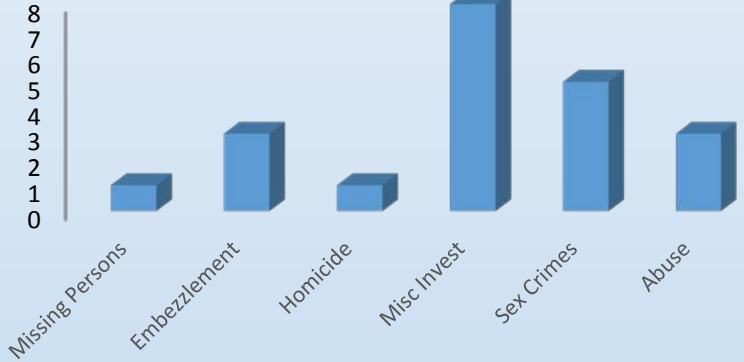

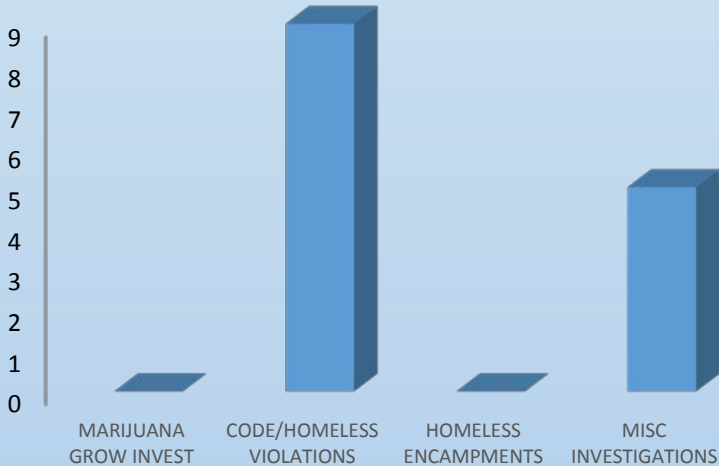

No Better Time

Almost every day, our local officers arrest someone for driving under the influence, and on New Year's Eve that number increases.

During the holidays, we want to celebrate with our friends and family, to remember the fantastic year we had and look forward to the promise of next year. But it is during the holidays when we can let down our guard and drive while impaired.

I can't think of a better time than right before New Year's Eve to remind everyone that driving can be risky—and using alcohol and drugs while driving can be downright dangerous.

Our officers have seen the horrific results of vehicle collisions, and they are passionate about removing intoxicated drivers from the road. Police officers don't want to be mean or unfair. In fact, it's just the opposite: they are committed to saving lives, lives we know can be taken when people drive while intoxicated.

Even if no one gets hurt or killed while a driver is impaired, DUI arrests and fines are expensive. A DUI can cost more than \$2,700 in court fines and fees, plus additional attorney's fees, 48 hours in jail, the time to complete an alcohol education program, and the loss of a driver's license.

So please, do the right thing this New Year's Eve and designate a sober driver to get everyone home safely. Decide early, who will drink and who will drive, or prearrange transportation with a taxi or through Uber.

If you are with friends who have not planned well and it appears they should not be driving home, don't take "no" for an answer. I know this can be tough. It can be incredibly awkward to tell a friend or family member they shouldn't drive. But please take a stand: do not let anyone drive while intoxicated.

I can assure you our officers will take a stand. We will do everything we can to prevent drunk driving.

Even if you haven't been drinking, driving while fatigued can lead to tragedy. The American Automobile Association says drivers with 5-6 hours of sleep a night had almost twice the crash risk of those with a full 7-8 hours. Drivers with only 4-5 hours of sleep a night had 4.3 times the risk, and those who got less than 4 hours of sleep during the last 24-hour period had 11.5 times the risk of being involved in a collision. Most alarming is that more than half of the drivers involved in these fatigue-related collisions had no warning before they fell asleep at the wheel.

Report of subjects camping under local bridge leads to out of county warrant arrests

UPD case # 17-3524

On December 20th at about 8:42 am, UPD officers were dispatched to under the Orr Street Bridge, on a report of subjects illegally camping. Upon arrival, officers contacted a male and female subject, who were camping in a tent. The officers recognized the female as Christine Sharp age 31 and the male verbally identified himself as "Timothy Tushuz" age 33. Officers suspected the male subject was not being honest about the name he provided and through investigation identified the male as Robert McKissick age 33. A subsequent records check revealed that Sharp had a misdemeanor warrant issued out of Amador County and McKissick a no bail felony warrant out of Sacramento for violating his parole and a felony warrant out of San Joaquin for robbery, bail set at \$500,000. Both Sharp and McKissick were taken into custody without incident and booked into the county jail.

Mayhem Arrest

UPD case # 17-3563

On December 24th, 2017, at about 5:50 PM Ukiah Police Officers responded to the 1100 block of North Oak Street for a reported physical altercation between family members. Responding officers contacted the 35 year old male victim and saw fresh blood running down his face, and noticed a portion of his ear was missing. Officers immediately requested an ambulance and the victim was transported to the hospital, where he was treated and later released.

The officers' investigation revealed the victim and a family member, identified as 40 year old Samuel Paul Galindo, were drinking alcohol together and engaged in a disagreement regarding a marijuana product. Galindo reportedly became enraged and forced the victim to the ground and began shoving his fingers into the victim's eyes. During the struggle Galindo told the victim repeatedly he intended to kill the victim, and bit off a portion of the victim's ear which Galindo then spit out.

The victim struggled free and Galindo grabbed a cylindrical object and held it in his fist and tried to punch the victim. The victim fled from Galindo, and Galindo ran after the victim yelling he was going to kill the victim. Galindo chased the victim until the victim was able to secure himself in a locked vehicle. Galindo repeatedly punched the vehicle's window again threatening to kill the victim.

Galindo was contacted at the scene and arrested without incident. Galindo was booked into the County Jail and charged with Mayhem, Assault with a Dangerous Weapon, Criminal Threats, and for Violating Parole.
